Farmers, Food and Freedom Under Attack... House Passes the 'Food Fascism' Bill, HR 2749

**We Have Three Weeks to Persuade the Senate
to Vote to Protect Food, Farmers and Freedom! Let's Use the Senate Recess!**

NOTE: If you have already taken this Action Item, we encourage you, and every member of your family and circle of contacts, to do so again since it has been amended to reflect the passage of HR 2749 on July 30, 2009 *after two failed attempts on the previous days). If passed by the Senate, this bill will lead to the loss of clean, healthy food and independent farming in the US and the complete industrialization of the US food supply.

Now the question is, "What will the Senate do?"

We managed to get some protective exemptions into the bill for small farmers selling food directly to consumers or to restaurants, but these are weak and will not be enough to protect your food, our farmers or our freedom. We need to rally people immediately to contact and/or visit their Senators - while they are home during the August recess - to demand accountable voting on this bill.

NO! TO THE FAKE "FOOD SAFETY" (sic) BILL HR 2749 or SENATE EQUIVALENT!

The Obama administration is pushing new farm controls which will drive small and independent farmers off the land, literally leaving the field to Agribiz, (implementing all of Codex through complete HARMonization and actually allowing the FDA to declare martial law) through Congress as fast as possible and have coordinated the bills so there will be little debate while committee meetings are closed to principled opposition.

Transparency, change, undoing Bush's restrictive regulations, giving the public time to comment, grassroots anything? Gone! None are visible in the current legislative process. Our entire food system, and thus our health, is being given away to the last people with any interest in quality or safety: Big Abgribiz. This is going on in the absence of public scrutiny. Those who do know what is happening, of course, have zero access to the process and to the major media. Meanwhile, the media is absent while Congress is moving at warp speed to sew this up.
